ENTRY FEE: \$400

WHO MAY ENTER: All registered ASA 18U teams across the Nation. One Berth given to USA ASA 18U Nationals in Moline, IL July 30 - August 3, 2008.

ENTRY DEADLINE: All entries must be postmarked by Friday May 23, 2008 so that pools and Double Elimination Brackets can be drawn at least 7-10 days ahead of tournament starting date.

FORMAT AND SCHEDULES: There will be a minimum of four (4) games scheduled for each team. Each team will play two (2) pool games with the Pool schedules established by blind draw and it will be posted by May 28th, 2008. A separate blind drawing will be done to establish Double Elimination Brackets and these Brackets will be posted by Friday, May 30, 2008. Pool play is not used to seed into double elimination as per National Tournament Format. We do expect college coaches to be in attendance.

ROSTER: All teams must be ASA Sanctioned and have fully completed rosters with ALL proper and required signatures, picture Identifications, and proof of team accident insurance. Without all of these required items; a team will not be allowed to participate.

CONDITIONS: The tournament committee reserves the right to change any game time, playing fields, dates, or make any other changes to conduct the tournament or accommodate circumstances beyond the organizers control, within the rules of ASA, in order to complete the tournament. The Tournament Directors, sponsors, and host all assume that all teams and their individual players are competing at their own risk, have their own insurance, and will not be held liable for any accidents or injuries. Entry into this tournament constitutes agreement to these conditions.

ADDITIONAL INFORMATION

TOURNAMENT UMPIRE IN CHIEF - Tommy Lewis – South Carolina ASA UIC.

EQUIPMENT REQUIREMENTS: All Batters must wear a NOSCE approved helmet and face guard.

PITCHING DISTANCE: ASA; As per ASA for 2008 -- Pitching Distance in 2008 is 43 foot.

GAME BALLS: Will be supplied by the Tournament. All teams will use the same ball.

GAME TIME LIMITS: All games will be played under the 1 hour and 40 time limit rule of National tournament format. No new inning will begin after 1 hour and 40 minutes. In case of a tie, the will be decided by the international tie breaker rule, regardless of inning.

RUN AHEAD RULE: A game is considered complete if one team is 15 or more runs ahead after 3 innings, 12 runs ahead after 4 inning, or 8 runs ahead after 5 innings.

PROTEST: All umpire judgment calls are final. A protest fee of \$200 must be posted at the time of a protest. If a protest is ruled in your favor your money will be returned.

PROOF OF AGE: Team manager is responsible to have at check in a picture identification of each player and proof of age and have available any time upon request.

PROOF OF INSURANCE: Each team is required to supply their own insurance and provide proof of insurance at check in and any time upon request.

GATE FEE: A daily adult gate fee of \$8.00 with a 3 day pass costing \$20. Children daily pass for 12 and under is \$4 with a 3 day child=s pass costing \$10. Children under 12 are free. This is an extremely nice park with concessions,, warm up areas, hitting stations, shaded areas, etc.

TEAM COOLERS: ONE DRINK AND ONE FRUIT COOLER PER TEAM IS ALLOWED.
No spectator or individual coolers allowed.
